

This is in partial response to your letter dated June 15, 1981 in which you requested, pursuant to the Freedom of Information Act, five categories of information regarding the Crystal River Plant and Babcock & Wilcox Company.

The documents listed on the aprendix are enclosed. During a July 8, telephone conversation with Mr. Stephen Isaacs of my staff, you were informed that the documents would not be identified individually with the specific items of your request.
