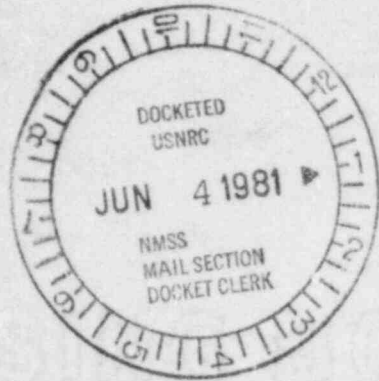

Dear Mr. McCorkle:

In your letter of April 9, 1981, we received route and port of call approval for shipments of irradiated reactor fuel being imported under license No. ISNM-1651.

We hereby request that this approval include two casks model JMTR-W 5200 (certificate No. USA/6393/B(m)FT) which will contain approximately 81 JMTR type fuel elements and are being imported under U.S.NRC license ISNM79007.

The shipment is expected to depart Liverpool, England on or about [redacted] and arrive in Portsmouth, Va. for unloading on [redacted].

Port of call as well as inland carrier, escort and destination details will remain the same as stated in our letter of March 24, 1981.
