The evaluation performed by Mississippi Power & Light Company for IE Bulletin No. 81-02 entitled "Failure of Gate Type Valves to Close Against Differential Pressure" to date has not identified any of the affected valves installed or yet to be installed in the Grand Gulf Nuclear Station Balance of Plant or being maintained as spares where they are required to close with a differential pressure across them in safety-related systems or as PORV block valves.

We request an extension until September 2, 1981, to allow time for the completion of MP&L's IE Bulletin 81-02 evaluation for the NSSS scope of supply for Grand Gulf Nuclear Station. Should you have any further questions regarding this matter, please advise.






