Dear Mr. Wiedeman:

Your letter of June 25, 1981, indicates that the inspection conducted by Dr. W. J. Adam on June 10, 1981, at St. Anthony's Medical Center revealed a violation that all elution, preparation, and injection areas were not surveyed for contamination on a daily basis. It is unfortunate that Dr. J. L. Bircher, the radiation safety officer, was not with Dr. Adam at the time this phase of inspection was conducted as he had been through most of the inspection. The technologist said that the entire department is only surveyed weekly and recorded on a diagram, but he did not realize at the time or show to the inspector that we have an addition 1 system for recording radiation surveys for each individual elution, preparation and injection in the form of an 8 x 5 inch file card for the generator, eluate, and each kit prepared daily itemizing each patient and including columns for individual surveys of kit preparation and eluate area as well as surveys of hands and clothing. This card file has been maintained since we began operation and numbers in the thousands.

Therefore, Dr. Bircher contacted Dr. Adam by phone on July 6, 1981, explaining the misunderstanding. Dr. Adam asked that we simply enclose a copy of one of our multiple dose disposition record file cards as evidence that we have been complying with the daily and individual radiation surveys, and I respectfully request that the notice of violation be rescinded.

I affirm the above statements are true.
