DEAR SIR:

I would like to thank you for your response, in sending me, two items, recently. (D.E.S.-NUREG 0769) - AND (D.E.S.-NUREG-0779). I NOW NEED A SINGLE COPY OF NUREG-0779, WHICH IS AVAILABLE FOR DISTRIBUTION. (CONCERNING - THE GRAND GULF NUCLEAR STATION IN MISSISSIPPI.)

AND, SIR, I WOULD ALSO REQUEST YOU TO HAVE MY NAME PLACED ON THE MAILING LIST, FOR SINGLE COPIES OF ANY FUTURE DRAFT REGULATORY GUIDES, AND VALUE/IMPACT STATEMENTS, WHICH MAY BE REPRODUCED FOR FUTURE DISTRIBUTION. (MY SPECIFIC DIVISION, IN WHICH MY STUDY RESEARCH IS CONCERNED, IS GEOLOGIC SITING OF FUTURE NUCLEAR POWER PLANTS) AND, ESPECIALLY, THE REPORTS THAT MAY BE AVAILABLE, CONCERNING SEISMIC STUDIES BY PRIVATE GROUPS OF SEISMOLOGISTS, IN THOSE AREAS WHERE PLANTS ARE TO BE PLANNED, AND CONSTRUCTED, AS WELL AS STUDIES CONDUCTED IN THE FIELD, BY U.S. GEOLOGICAL SURVEY, (OR OTHER U.S. GOVT SEISMOLOGISTS), AFTER CONSTRUCTION, AND LICENSING, OF THESE FUTURE PLANTS.

FURTHERMORE, I AM MAKING FURTHER INQUIRY, CONCERNING MY LETTER TO YOU, SIR, OF JUNE 2, 1981, IN WHICH I HAD REQUESTED TWO ITEMS, IN ADDITION TO, THE TWO NUREGS THAT YOU SUBSEQUENTLY SENT ME. YOUR OFFICE ALSO INCLUDED A PHOTOSTATIC COPY OF MY LETTER TO YOU, OF JUNE 2, 1981. AND ON IT, YOU MENTIONED THAT THESE TWO ITEMS WERE REFERRED TO - P.D.R. I DO NOT UNDERSTAND, WHAT THIS MEANS, SINCE I DID NOT RECEIVE ANY LETTER, CONCERNING THE TWO REPORTS THAT I HAD REQUESTED OF YOUR OFFICE.

These two items which I had requested were concerned with the Virgil C. Summer Nuclear Station Unit No. 1, in South Carolina. (NUREG No. 0534)

Since the region in South Carolina (and North Carolina, as well, by now), contains about one dozen Nuclear Power Plants, - and, SIR, since this area, is Not an exceptionally quiet earthquake-prone zone; and, SIR since, the letter, that I read, (which is in your NUREG No. 0534, pages H-134, 135, and 136, sent to your Agency by the U.S. Dept of Interior), specifically covers geology, - and further, states, "that, the applicant's Preliminary Safety Analysis Report, - which discusses the geologic and seismological investigations and analyses that have been performed for the Virgil C. Summer Station".

I would, if possible, like to receive that above mentioned (applicant's Preliminary Safety Analysis Report. Also, my second request, in the study I am making about this region, in South Carolina, concerns, any available final Seismic Studies, and Report Data, done in the field area, of that, (and possible other Nuclear Power Plants in South (and North Carolina regions), done by, - the U.S Geological Field Survey teams of Seismologists.

The only other comment, I can offer at this time, is, - that nowhere, in NUREG'S 0534, OR IN, NUREG 0769, OR, NUREG 0779 is there A SINGLE word, sentence, paragraph, or Report of any SEISMIC (EARTHQUAKE) studies made, prior to construction, or during construction, or, subsequent licensing. And, although your tremendous amount of data concerning the public safety from Radiation (by Accident), or environmental safety to, the

fish, wildlife, agriculture, plants, etc, etc, is vociferously, in great detail, fully, analyzed, and responded to.

Why, none of these D.E.S. Manuals, exclude this tremendously important data, (since, in the past 5-6 years alone, the U.S. Geological Survey has recorded data, of Between 3-4 EARTHQUAKES, in one of the 50 states, every day of each year, since 1975) — I am sure you can understand, my personal concern, which we all should have, (since, NRC inspection teams CAN NOT predict, when, or where an earthquake can strike), about where, power plants, involving Nuclear materials, are placed (in areas of seismic activities), especially, since that North and South Carolina Region does have so many plants.

Hoping you can expedite my requests for additional study materials, (as requested above) — and, again, thanking you in advance, for any prompt cooperation, I am,

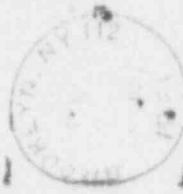
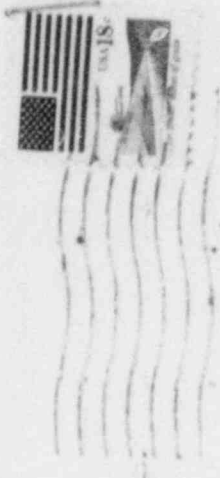
