This refers to the inspection conducted by Mr. J. I. Tapia of our staff during the periods May 19-22 and June 3-11, 1981, of activities authorized by NRC Construction Permits CPPR-128 and CPPR-129 for the South Texas Project, Units 1 and 2, and to the discussion of our findings with Mr. M. E. Powell and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.
