This refers to the inspection conducted by Mr. Wm. D. Keller of this office on April 6-9, 1981, of your facility at Whittier, California, and to the discussions of our findings with you and members of your staff at the conclusion of the inspection.

This inspection was made as a result of the issuance of 10 CFR Part 21 Reports pertaining to electric motor shaft failures during Containment Gas Monitoring System unit testing.

Areas examined during the inspection and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we found no instance where you failed to meet NRC requirements.
