WE ARE LONG TIME RESIDENTS OF SAN LUIS OBISPO NOT PLANNING TO PARTICIPATE IN THE BLOCKADE AS RESPONSIBILITIES WILL NOT ALLOW US THE TIME. THIS IS OUR WAY OF GOING ON RECORD TO REGISTER OUR PROTEST, THERE ARE MANY MORE LIKE US IN THE COMMUNITY.

YOU HAVE ALREADY HEARD SOME OF OUR REASONS - PLEASE WHEN YOU DECIDE THINK OF THE FUTURE. IF IN NO OTHER CAPACITY THAN THE LONG TERM COST OF SUCH IDIOSY. IT IS TRULY FISCAL IRRESPONSIBILITY THAT WILL IN THE END BE ABSORBED BY THE TAXPAYERS AS IN 3 MILE ISLAND. IT NEVER IS THE RESPONSIBILITY OF THE UTILITY COMPANY, REGARDLESS OF THE HEALTH & SAFETY ISSUES (BOTH VALID), THE CONSTANT SHUTDOWNS OF THE 2 NUCLEAR PLANTS IN CALIF.
