This inspection was made to confirm that, in the areas inspected, your QA program, is being effectively implemented. The inspection effort is not designed to assure that unique quality requirements imposed by a customer are being achieved; nor to assure that a specific product, component or convice provided by you to your customers, is of acceptable quality. As you know, the NRC requires each of its lifensees to assume full responsibility for the quality of specific products, components or services procured from others. You should, therefore, not conclude that the NRC's inspection we want you from inspections by an NRC licensee or his agents, nor from takin, effective corrective action in response to their findings.

Areas examined during the inspection and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.
