This is in reply to your letter to me dated July 31, 1981, concerning the location for the Advisory Committee on Reactor Safeguards (ACRS) subcommittee meeting for the Shoreham Nuclear Station.

Your letter references my letter to the Shoreham "service list" dated June 22, 1981. In that letter I advised that the location for the ACRS subcommittee meeting in question, originally scheduled for July 21, 1981, had been relocated from the Holiday Inn in Riverhead, New York to Washington, D.C.
