Gentlemen:

This refers to the inspection conducted by H. W. Roberds of this office on March 10-13, 1981, of your facility at Cleveland, Ohio, associated with the fabrication of standby gas treatment systems and to the discussions of our findings with you and members of your staff at the conclusion of the inspection.

This inspection was made as a result of: (1) the issue of a 10 CFR Part 21 report pertaining to the identification of defects in a temperature detection unit type, that had been installed in equipment furnished to the Hartsville and Palo Verde Nuclear Generating Stations; (2) the identification of incorrect connection of differential pressure gages in air clean up units furnished to Bellefonte Units 1 and 2; (3) the identification of defective Flanders Filters charcoal adsorber trays at Sequoyah Units 1 and 2; (4) the identification of separation of screens from charcoal adsorber frames at the Phipps Bend and Hartsville Nuclear Stations; and (5) the identification of inadequate fire protection system drains in standby gas treatment charcoal adsorbers furnished to the Phipps Bend and Hartsville Nuclear Stations.

Areas examined and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection it was found that the implementation of your QA program failed to meet certain NRC requirements. The specific findings and references to the pertinent requirements are identified in the enclosures to this letter.

Please provide us within 30 days of the date of this letter a written statement containing, (1) a description of steps that have been or will be taken to correct these items, (2) a description of steps that have been or will be taken to prevent recurrence, and (3) the date your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for good cause shown.
