Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

If this report contains any information that you (or your contractors) believe to be exempt from disclosure under 10 CFR 9.5(a)(4), it is necessary that you (a) notify this office by telephone within ten (10) days from the date of this letter of your intention to file a request for withholding;

and (b) submit within 25 days from the date of this letter a written application to this office to withhold such information. Consistent wit' section 2.790(b)(1), any such application must be accompanied by ar .ffidavit executed by the owner of the information which identifies the document or part sought to be withheld, and which contains a full statement of the reasons or the basis which it is claimed that the information should be withheld from public disclosure. This section further requires the statement to address with specificity the considerations listed in 10 Cr R 2.790(b)(4). The information sought to be withheld shall be incorporated as far as possible into a separate part of the affidavit. If we do not hear from you in this regard within the specified periods noted above, the report will be placed in the Public Document Room.
