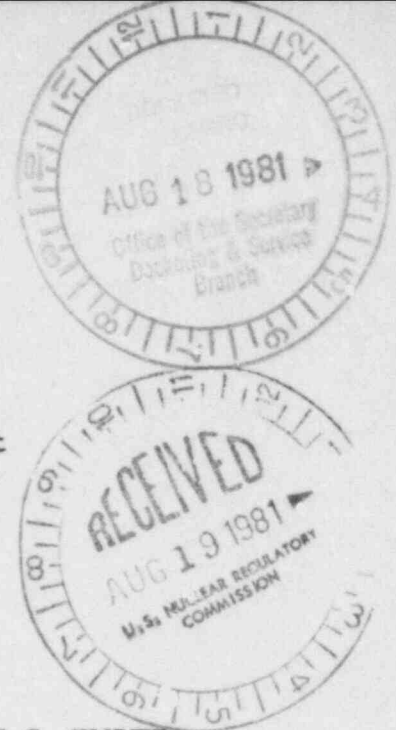
PEOPLE OF THE STATE OF ILLINOIS'

includes all other documents which are attached to or relate to such documents,
including but not limited to drafts of the described documents. The term "NRC Staff"
includes the United States Nuclear Regulatory Commission, its staff, members, attorneys,
employees, consultants, divisions or subdivisions, contractors and subcontractors.

3. All working notes and/or calculations made or done in connection with the preparation of the said report.


4. All memos, notes, and other writings relating or referring to the said report.
