This refers to the routine safety inspection conducted by Mr. J. Thomas of this office on July 1 - August 3, 1981 at the Oyster Creek Nuclear Generating Station, Forked River, New Jersey of activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Thomas with Mr. J. Carroll and other members of your staff periodically during, and at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the item of non-compliance brought to your attention in the enclosure to our letter dated May 29, 1981. We have no further questions regarding the steps you took to correct item

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements as set forth in the Notice of Violation, enclosed herewith as Appendix A. These items of noncompliance have been categorized into the levels described in the Federal Register Notice (45 FR 66754) dated October 7, 1980. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A. In addition to the need for corrective action regarding these specific items of noncompliance, we are concerned about the implementation of your management control systems that permitted them to occur. Consequently, in your reply, you should describe in particular, those actions taken or planned to improve the effectiveness of your management control systems.

If we do not hear from you in this regard within the specified periods noted above, the report will be placed in the Public Document Room.
