Dear Sir:

The enclosed revised Physical Security Plan for the reactor facility at Iowa State University is submitted for review and approval. Implementation can begin as early as September 1, 1981. Pursuant to paragraph 2.790(d) of 10 CFR Part 2, the Plan is to be withheld from public disclosure.

The original version of the Physical Security Plan was submitted with the application for renewal of the reactor operating license (R-59) by letter dated September 5, 1979. Upon review by the Staff, several areas of the proposed Plan were found to be in need of correction or clarification. These were initially communicated by telephone by Mr. Donald Carlson on January 15, 1980, and subsequently discussed on other occasions. Provisions of the revised Plan which did not conflict with the approved Security Plan have been implemented and successfully tested over the intervening period.

All areas found to need correction or clarification have been studied and rewritten in the revised version of the Plan. A summary of changes is attached.
