Gentlemen:



The changes which make up this revision are a result of further refinement of the plan, incorporating both NRC and in-house comments. 



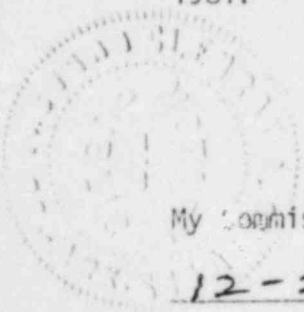
