The purpose of this modification is to provide incremental funding in the amount of \$280,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation--Cost Reimbursement (JUNE 1988) ALTERNATE I (JUNE 1988), paragraph b. is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"b. The amount presently obligated by the Government with respect to this contract is \$517,000.00."

All other terms and conditions, including the contract ceiling amount of \$579,429.00, remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
