On March 13, 1990, we issued the inspection report which provides the written results of our January 1990 inspection of AMS' licensed activities. Please advise us if this date is still acceptable. If not, please provide us an alternative date.

NRC attendees at the conference will include Mr. A. Bert Davis, Regional Administrator, Bruce Mallett, John Grobe and Wayne Slawinski of the Region III staff, and representatives from our Offices of the General Counsel and Enforcement. We would like to tour the AMS London Road facility at 9:00 a.m. and hold the enforcement conference at 1:00 p.m. in a meeting room in the Holiday Inn near the AMS facility.
