Dear Mr. Elliott:

Enclosed is an order entered today by the Nuclear Regulatory Commission's Atomic Safety and Licensing Appeal Board in connection with the above-referenced proceeding. The order invites the Environmental Protection Agency to file a brief amicus curiae in connection with the pending administrative appeals.

By way of background, the Atomic Safety and Licensing Board (the trial level board that presided at the evidentiary hearing) authorized an amendment to the materials license held by the Kerr-McGee Chemical Corporation for its West Chicago Rare Earths Facility. amendment permits the onsite, above-grade, permanent disposal of some 376,400 cubic meters of radioactive thorium mill tailings and other radioactively contaminated materials on twenty-seven acres of the West Chicago site, a location in the midst of a residential area of the City of West Chicago, Illinois. A copy of the Licensing Board's February 13, 1990, initial decision also is enclosed. The State of Illinois and the City of West Chicago, which participated to varying degrees in the hearing, have appealed the Licensing Board's initial decision to the Appeal Board. Because the EPA commented on the NRC's Draft Environmental Statement on Kerr-McGee's disposal proposal and pertinent NRC regulations (10 C.F.R. Part 40, Appendix A) involved in this proceeding incorporate EPA regulations (40 C.F.R. Part 192, Subparts D and E), the Appeal Board believes that the views of the EPA might prove of material assistance to it in resolving these appeals. Thus, the Appeal Board is hopeful that the EPA will accept the invitation.

In this regard, the Board would like any EPA brief to be filed and served by express mail or comparable means (see 10 C.F.R. §§ 2.701, 2.712) by either April 19 or May 21, 1990, depending upon the position that EPA takes. The Board would appreciate it greatly if the EPA files its brief by the applicable date. Should the EPA find it impossible to meet the deadline, however, the Board will entertain a motion for an extension of time. See 10 C.F.R. § 2.711.
