Ladies and Gentlemen:


Pursuant to 10 CFR 52.103(a), Southern Nuclear Operating Company (SNC), the licensee for Vogtle Electric Generating Plant (VEGP) Unit 3 Combined License (COL) Number NPF-91, is hereby notifying the U.S. Nuclear Regulatory Commission (NRC) of the scheduled date for initial loading of fuel at VEGP Unit 3 on November 23, 2020. SNC is submitting this notice in parallel with the Notice of Uncompleted Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) to support publication of the notice of intended operation 285 days prior to scheduled fuel load. SNC respectfully requests that the notice of intended operation be published in the Federal Register in accordance with 10 CFR 52.103(a).

Updates to the scheduled date for initial loading of fuel will be made every 30 days in accordance with the 10 CFR 52.103(a) and VEGP Unit 3 COL condition 2.D.(11).

This letter contains no regulatory commitments. This letter has been reviewed and confirmed to not contain security-related information.
