This refers to your license amendment request dated September 16, 2019. Please find enclosed Amendment No. 21 adding temporary storage not to exceed 1 year incident to transfer of germanium-68 sources in accordance with 10 CFR 30.41, and decay-in-storage in accordance with 10 CFR 35.92 for strontium-82 and -85 waste at your Owasso, Michigan site.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
