Our office has reviewed Kalamazoo College's (your) January 6, 2020 letter (ML2008D875) requesting to list you as Radiation Safety Officer (RSO) and requesting to remove the current RSO, James A. Langeland, Ph.D., on the referenced license. Please note that additional information is needed to complete our review. Accordingly, we are please respond to the items below:

1. Regarding the request to remove Dr. Langeland as RSO, from Condition No. 11, should he also be removed as an Authorized User (AU) from Condition No. 12?
2. Regarding the request to add you as RSO, to Condition No. 12, please provide additional documentation, description, or explanation or your training and experience, as available:
 - Supervised work experience in RSO duties, as applicable to the referenced license. Please include whether the experience was with Dr. Langeland at Kalamazoo College, or at other location. Please include dates of the experience and locations – if other than at Kalamazoo College.
 - Hands-on experience with the Model NER-580 – or similar – sealed cobalt-60 source including dates of that experience, supervising AU or RSO, and a description of the experience.
 - Any additional formal training applicable to the RSO duties to be performed, under the referenced license.
3. Regarding the request to add you as RSO, please provide contact information:
 - Your phone number, fax number, and email address (if other than the one used in this message to you).
 - A name, title, phone number, fax number, and email address for a second contact person – if available – for your license.

Please provide the requested information within 14 days of this message (on or before February 4, 2020). Include a signed and dated cover letter transmitting your resubmitted application. Submission of your response as a pdf file attached to an email or via facsimile will allow for the quickest processing. Please call or email me with any questions you may have, or if you are unable to respond by the date suggested

above. Please also contact me as soon as possible to let me know that you have received this message and are working on a response.
