Subject: Inspection No. 82-01

This refers to the routine safety inspection conducted by Mrs. Teresa Hall Darden of this office on October 6, 1982 of activities authorized by NRC License No. 07-02815-04 and to the discussions of our findings held by Mrs. Darden with yourself and Mr. William R. Brown of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mrs. Darden and Ms. Emily Perrone on October 14, 1982.

The inspection was an examination of activities conducted under your license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you had taken to correct the violations brought to your attention in a letter dated April 5, 1977. We have no further questions regarding the steps you took to correct item A. With regard to items B and C, these items have recurred.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. These violations have been categorized by severity level in accordance with the NRC Enforcement policy (10 CFR 2, Appendix C) published in the Federal Register Notice (47 FR 9987) dated March 9, 1982. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Item B in the Notice of Violation enclosed with this letter was identified during a previous inspection were documented activities on March 29, 1977 and was in the enclosure to our letter dated April 5, 1979. Your letter to this office dated April 25, 1977 stated that Radiation Safety Committee meetings would be held semi-annually. From our October 6, 1982 inspection it appears that the stated corrective actions were not effective since this item has not been fully corrected. Recurrent and uncorrected violations are given additional weight in the consideration and selection of appropriate

enforcement action. Therefore, in your response to this letter, you should give particular attention to those actions taken or planned to ensure that identified items of noncompliance will be completely corrected and will not recur.

From the discussions conducted during the inspection, it is our understanding that you plan to submit a request for a license amendment naming Emily Perrone as the designated Radiation Protection Office. We will review this matter during the next inspection.




