This refers to the routine inspection conducted by Messrs. D. P. Haist and J. F. Burdoin of this office on March 14-17, 1983, of activities authorized by NRC Construction Permit No. CPPR-154, and to the discussion of our findings held by Mr. Haist with Mr. O. E. Trapp and other members of your staff at the conclusion of the inspection.
