This refers to the special safeguards inspection conducted by Mr. W. J. Tobin of this office on May 24 - 26, 1983, of activities authorized by NRC License No. NPF-9 at McGuire Nuclear Station and to the discussions of our findings held with Mr. M. D. McIntosh, Station Manager, at the conclusion of the inspection.

Areas examined during this inspection included your physical security program as implemented under the provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials" and the specific requirements of your approved Security Plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspector.

Within the scope of this inspection, no violations or deviations were disclosed.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material, with the exception of the report cover page which is an inspection summary, will not be placed in the Public Document Room.
