Dear Mr. Kuron:

I am writing in response to your letter to the U.S. Nuclear Regulatory Commission dated October 1, 1978. It is my understanding, after talking with your wife by telephone on November 1, 1978, that you seek permission to make a limited appearance at any public hearing involving the application for an operating license for the Fermi 2 facility.

Under the Commission's Rules of Practice, persons desiring to make limited appearances, in the form of oral or written statements, are permitted to do so at the discretion of the presiding officer. The presiding officer's discretion also extends to the order in which limited appearance statements may be received and any limits upon the length of such statements. The presiding officer has scheduled a prehearing conference to discuss the intervention petitions filed in this proceeding on Monday, December 18, 1978, at 10:00 a.m. in Judge Patton's Courtroom (Room 1057), U.S. Courthouse, 231 West Lafayette Street, Detroit, Michigan, and has indicated that limited appearance statements may be presented at that time. Should you be unable to attend the prehearing conference or desire any further information, it is recommended that you contact Charles Bechhoefer, Esq., Chairman of the presiding Atomic Safety and Licensing Board, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555.

If you desire that written material be incorporated in the record as part of your limited appearance, it is suggested that you address your proposal to the Atomic Safety and Licensing Board at the time you make your limited appearance. It would be helpful if you were to have extra copies of any such written material available for the hearing reporter. About 30 copies are normally required to meet the reporter's needs.


