Enclosed are copies of the exercise evaluations prepared by the Federal Emergency Management Agency (FEMA) Regions III and V, on the offsite emergency preparedness exercises conducted on February 17, 1982, July 14, 1982, and August 24, 1982, at the Beaver Valley Nuclear Power Plant.

The Region V exercise evaluations contain a discussion of the deficiencies noted at the <u>Columbiana County</u> and Ohio State levels. It was not demonstrated at either the February or July exercise that the population in the Region V area can be adequately protected in the event of an accident. Region V is now pursuing a schedule of corrective actions with the State of Ohio and we expect the State's report later this month. The next exercise to evaluate the corrective actions is scheduled for February 16, 1983

FEMA Region III is in the process of requesting a schedule of corrective actions from both Pennsylvania and West Virginia. This information will be forwarded to you as soon as we receive it. After you have reviewed the attached material, I feel it would be advisable for our staffs to meet and discuss the current status of corrective actions underway and the exercise scheduled in February to test preparedness at this facility.

Attached are Edwin W. Hakala's comments regarding the performance of Columbiana County (Ohio) during the Beaver Valley Radiological Emergency Preparedness Exercise, conducted February 17, 1982.

My conclusion is that Columbiana County did not demonstrate it could protect the public in the event of an accident at the Beaver Valley Nuclear Power Plant. This is based on the comments offered by Mr. Hakala and the limited participation of Columbiana County during this exercise. Also, the State of Ohio did mt participate in this exercise.

FEMA Region V Observer Comments at the Columbiana County, Ohio, Disaster Services Agency Participation in Beaver Valley, Pennsylvania, Nuclear Power Plant Radiological Emergency Preparedness Exercise February 17, 1982

The Columbiana County, Ohio, Disaster Services Agency participated in the Beaver Valley Nuclear Power Plant radiological emergency preparedness exercise only to the extent of utilizing alerting and notification, and communications procedures. The Ohio Disaster Services Agency had previously indicated to the Regional Director, FEMA Region V, that it would not participate in this exercise, nor did it recommend Columbiana County's participating therein.

The Columbiana County Disaster Services Agency was represented by its director, a communications officer and a radiological defense officer. The staff was later joined by the Red Cross full-time chapter employee. In the later part of the exercise, an additional volunteer communications staff member reported for duty.

The Columbiana County emergency operations center is extremely marginal from the standpoint of criteria normally expected of an EOC. The director used both commercial telephone and radio backup in all communications activities. He received all calls relative to changes in plant operational status within reasonable times and took action to alert his emergency call lists as each level changed. He received calls from the East Liverpool city civil defense organization on a routine basis, and in the later stages of the exercise dispatched a communications staff member to meet with a Red Cross volunteer at a selected reception and care site. The County Sheriff arrived at the EOC mid-morning and remained for at least an hour. There was evidence of a good cooperation between the director and sheriff.

It was apparent from the overall situation at the EOC with its lack of equipment and related problems, that there were not enough funds available for a better site. The civil defense director said he had a budget of "\$17,000 a year" on which to work.

It is apparent that Columbiana County's full, effective participation in REP exercises can only be attained through some technique wherein additional funds are provided for the necessary equipment, structure, and staff. This probably can be achieved only through a meeting of Columbiana County officials, representatives of the Beaver Valley nuclear power facility, and Ohio Disaster Services Agency officials.
