Dear Mr. Hallock:

This letter refers to your application, U.S. Nuclear Regulatory Commission (NRC) Form 313, dated October 14, 2019, requesting a new exempt distribution license to authorize the distribution of lamp products containing krypton-85 and thorium. We requested additional information regarding your request by letter dated November 14, 2019, and received a response dated January 6, 2020. On January 10, 2020, we sent an email with additional questions based on that response.

As of the date of this letter, we have not received any further response to our questions. As I mentioned in a telephone conversation with Mr. Jack Buddenbaum on December 3, 2019, or a subsequent follow up call, the deadline for the close-out of the open task concerning your application is January 29, 2020. Therefore, we have suspended your amendment request review at this time pending your response to the requested information. We will review your response when we receive the requested information. This action is taken without prejudice to the resubmission of your request. Please note that when you resubmit your application at a later date, you may refer to Mail Control Number 616865 for the documentation you have already submitted.
