To whom it may concern:

On behalf of Bayamón Imaging and Interventional Institute LLC (the "Company"), we hereby notify the U.S. Nuclear Regulatory Commission (the "Commission") that the Company intends to purchase within the next thirty (30) days all of the issued and outstanding shares of capital stock of MRI Center, P.S.C., CT Radiology Complex, Inc. ("CT Radiology") and Sky-View Realty, Inc. (collectively, the "Operating Entities") from Dr. Liana R. Medina Pizarro (the "Seller").

Upon the closing of this proposed acquisition, the Company will be in control of the Operating Entities. CT Radiology (d/b/a as C.T. Radiology Complex & MRI Institute) is the licensee of NRC License 52-14931-01 (the "NRC License").

Following the transaction, CT Radiology will continue being the licensee for all licensed activities under the NRC License. The Company will retain all the employees and officials of CT Radiology and will not change the licensee's location, equipment or procedures.


