This refers to the inspection conducted by Messrs. E. Johnson, J. Jaudon, C. Trammell, C. Willis, S. Showe, G. Lanik, and R. Young of the NRC during the period September 7-17, 1982, of activities authorized by NRC Facility Operating Licenses DPR-51 and NPF-6 for Arkansas Nuclear One, Units 1 and 2.

Areas examined during this inspection are documented in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures, correspondence, drawings, representative records, interviews with personnel, and observations by the inspectors.
