As discussed in an April 8, 1994, telephone conversation between Mr. Jerry D. Ennis, Region II, and LCDR G. Higgins of your staff, we are forwarding the enclosed information for your review and appropriate action. The NRC has not made an attempt to ascertain the accuracy of the information supplied.

The enclosed information is not being placed in the Public Document Room. Appropriate safeguards must be applied to the enclosed information in view of its unsubstantiated nature in order to avoid an unwarranted invasion of privacy or defamation of character of named or otherwise characterized individuals. In view of the fact that the information is related to the transportation of hazardous material, it is also being provided to the U.S. Department of Transportation for information.

You are requested to review this information and provide us the results of your findings within 45 days of the receipt of this letter. Your evaluation should be performed by an individual or organizational entity outside the organization where the alleged event took place. The evaluation should be thorough, objective and sufficient in scope and depth to resolve the issue. The evaluation should consider the root cause and generic implications of the information, if it was substantiated.

In order to assure appropriate protection of the information, please mark the letter with your findings as containing "Information Exempt From Disclosure Under 10 CFR 2.790(a)(6) and (7)." Indicate on the envelope that it is "TO BE OPENED BY ADDRESSEE ONLY."
