Subject: Western Soil, Inc. 1/28/2019 Telephone Record - Confirmation of Receipt of NRC Order Revoking License For Non Payment of Fees

Discussion: I contacted Mr. Max Laracuenta Bernat and confirmed that he received the “NRC Order Revoking License For Non Payment of Fees” (Order). I explained to him that his acknowledgement of receipt of the Order starts an enforcement clock and that he has 60 days to transfer the gauge to a licensed entity. After that time-period, NRC will initiate appropriate enforcement actions. I also sent him an email which contained step-by-step instructions for searching for other NRC licensees who possess CPN MC1 gauges, so he could contact those licensees to inquire about possible transfer of the gauges. Mr. Laracuenta emphasized that the gauges are securely locked up in Puerto Rico.

Action Required: Mr. Laracuenta committed to working to transfer the gauges within 60 days.
