SEP Topic II-3.A, Hydrologic Description
SEP Topic II-3.B, Flooding Potential and Protection Requirements

In Reference (1) the Staff requested additional information related to SEP Topics II-3.A, Hydrologic Description, and II-3.B, Flooding Potential and Protection Requirements for the Haddam Neck Plant and Millstone Unit No. 1.

In accordance with this request, Connecticut Yankee Atomic Power Company (CYAPCO) and Northeast Nuclear Energy Company (NNECO) are providing the attached drawings. An index of the enclosed drawings is included.

CYAPCO and NNECO are concerned that information requests of this type are time consuming to respond to and could potentially impact on our commitments for the redirected SEP. It was our understanding that information requests and subsequent written iterations would not be necessary on the SEP topics for which CYAPCO and NNECO would provide the Safety Assessment Report. It is our feeling that these requests are not in keeping with the original guidelines for the redirected SEP.
