INTERIM REPORT

Description of Deficiency

All of the Stress Reports of Load Capacity Data Sheets (required by ASME Section III subsection NF-3141.2) for hangers provided by Nuclear Power Services Co. (NPS) have not been made available to Burns and Roe Engineering for review. There exists a concern that use of the manufacturer's catalog load capacity data sheets may be unconservative and result in over-stressed conditions for Component Standard Supports.

Approach to Resolution of the Deficiency

Stress Reports of Load Capacity Data Sheets will be reviewed for adequate design and appropriate action will be taken if the design is found to be deficient.

Status of Proposed Resolution

Several requests have been made to the manufacturer for the necessary information. To-date, all the required information has not been received. Bechtel (Construction Manager) is being requested to assist in our efforts.

Reason for Delay of Final Report

We are awaiting the receipt of the Stress Reports prior to making an evaluation.

Projected Completion of Corrective Action and Submittal of Final Report

An update will be issued on this matter by September 18, 1981.
