This change will modify collection of data obtained for the particular replicate sampling points and the time given for taking the samples within the spawning peaks in the shcreline seine program.

The revised pages of the ANO-1 Environmental Technical Specification are included with vertical lines denoting the changed items.



## BASIS FOR CHANGE

Due to heavy vegetative growth in the Backwater Control Area (Area A), it is becoming impossible to perform replicate sampling in the area. In studying the seine results from 1974 through 1980, the replicate samples over a long period of time show very similar results. Thus, we feel replicate samples are not needed and request dropping the two samples in each area and go to only one sample in each area.

When the shoreline seine program was first developed, it was thought that sampling should begin in March to be sure that spawning peaks would be detected. In analyzing the data and in discussions with the contract agent at Arkansas Tech, the sampling appears to be unwarranted. Very few fish are caught in March. The spawning peaks occur in May and June. Therefore, we feel that sampling should begin in April. We are requesting deletion of the month of March from the shoreline seine program and begin sampling in April.
