Dear Sir:

In accordance with 10 CFR 50.54(q), the Authority, as licensee for the Indian Point 3 Nuclear Power Plant submits herewith three copies of the revised Westchester, Rockland, Orange and Putnam Counties radiological emergency response plans. Ten additional copies of each of the aforementioned emergency plans are being concurrently submitted to the Director of Nuclear Reactor Regulation. These plans replace those plans previously submitted by the Authority on December 30, 1980.


In addition, the appropriate number of copies of the revised "Indian Point Site - Site Specific Operations" section of the New York State Radiological Emergency Preparedness Plan are being submitted in accordance with 10 CFR 50.54(q). Copies of the revised New York State Radiological Emergency Preparedness Plan, without the "Indian Point Site-Site Specific Operations" section, were previously submitted by Niagara Mohawk Power Corporation for their Nine Mile Point Nuclear Power Plant, Unit 1. As discussed with the NRC emergency preparedness team leader for the Indian Point 3 Nuclear Power Plant, to minimize duplication the Authority will not submit additional copies of the aforementioned Niagara Mohawk Power Corporation submittal.
