Besse 2,3, Hope Creek, and Pilgram 2 facilities. Article II - the period of performance is extended from 30 September 1981, to 06 November 1981. Pursuant to the foregoing, the total amount of subject contract is increased from \$105,000.00 to \$115,000.00, a total increase of \$10,000.00.
