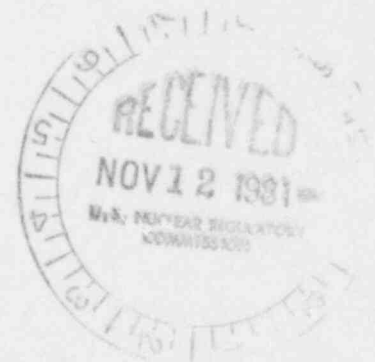
The Bronx Chamber of Commerce respectfully requests they be permitted to make a limited appearance in regard to Docket numbers 50-247-SP and 50-286-SP.
