This refers to the inspection conducted by Mr. J. P. Jaudon of our staff during the period October 13-16, 1981, of activities authorized by NRC Facility Operating License DPR-34 for the Fort St. Vrain Nuclear Generating Station, and to the discussion of our findings with Messrs. E. Hill and J. W. Gahm and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of the inspection, no violations or deviations were identified.

One new unresolved item is discussed in paragraph 4 of the enclosed report.
