14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$160,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B.1, Consideration and Obligation, the first sentence of paragraph b. is deleted in its entirety and the following sentence is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$660,525.00."

All other terms and conditions, including the contract ceiling amount of \$700,000.00, remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
