SUBJECT: LIST OF LICENSEE FILES TO BE RETAINED PERMANENTLY

In the Records Management Guideline 92-01, "Plan for Decommissioning Records," dated March 16, 1992, there are two action items assigned to NMSS. One item is for NMSS to develop criteria for determining which records files should be retained permanently. We agree with the IRM recommendations for including records that have historical importance or substantial public interest. We recommend that licensees listed in the Site Decommissioning Management Plan (SDMP) be included as having historical importance and substantial public interest. We assume that all previously terminated license files will be retained permanently, as NMSS previously recommended to IRM.

The other item is the preparation of a list of licensee files that would be retained permanently. In response to this action item, we are providing a list of those licenses (for which LLWM has project management responsibility), that are listed in the SDMP, are of historical value, or are of great public interest. Our list is provided in the Enclosure.
