SUBJECT: REPLY TO A NOTICE OF VIOLATION

(NRC INSPECTION REPORT NO. 42-25214-01/93-01)

IN RESPONSE TO YOUR LETTER, NOTICE OF VIOLATION, RECEIVED JANUARY 23, 1993.

1) A WRITTEN EXPLANATION FOR THE REASON OF VIOLATION: (A)

VIOLATION OCCURANCE WAS IN PART ATTRIBUTED TO THE FACT THAT THE THREE (3) INDIVIDUALS INVOLVED WERE CHIEFLY WORKING IN A DIVERSA METHOD OF N.D.T. OTHER THAN RADIOGRAPHY. AT THE TIME THE AUDIT'S WERE CONDUCTED THE THREE (3) INDIVIDUALS WERE NOT PART OF OUR DAILY RADIOGRAPHIC OPERATIONS AND THE ONLY UTILIZED ON WEEKENDS AS WORK LOAD NECESSITATED.

- 2) CORRECTIVE GIEPS THAT HAVE BEEN TAKEN AND THE RESULTS ACHIEVED:

TO CORRECT THE PROBLEM, TEHCNICAL WELDING LABORATORY, ST. CROIX HAS INSTITUTED A POLICY TO UTILIZE THE INCOMING TLD REPORTS AS A CHECK LIST TO INSURE EVERY MONITORED EMPLOYEE IS GIVEN A FIELD AUDIT WITHIN THE REQUIRED NINETY (90) DAY PERIOD.

4) DATE WHEN FULL COMPLIANCE WAS ACRIEVED:

TECHNICAL WELDING LABORATORY, ST. CROIX LAST QUARTERLY FIELD AUDIT WAS PERFORMED OVER THE PERIOD OF NOVEMBER 13, 1992 THRU NOVEMBER 18, 1992. AFTER OUR AUDIT ON JANUARY 05, 1993 LY MR. FULLER, WE IMMEDIATLY CONDUCTED A FIELD AUDIT FROM JANUARY 06, 1993 THRU JANUARY 18, 1993 TO INSURE THAT ALL RADIOGRAPHER'S AND ASSISTANT'S HAD BEEN AUDITED AND WERE IN FULL COMPLIANCE

1) A WRITTEN EXPLANATION FOR THE REASON OF VIOLATION: (R)

PON RECEIVING THE VIOLATION, WE IMMEDIATLY WENT TO OUR FILES AND REVIEWED THE INSPECTION AND MAINTENANCE RECORDS ON THE TWO (2) EXPOSJRE DEVICES IN QUESTION, SERIAL #114 & #293. INSPECTION WAS CONDUCTED ON AUGUST 08, 1992. THE INSPECTION WAS RECORDED ON THE SAME PAPERWORK AS THE JULY 09, 1992 INSPECTION. THEREFORE THE NOVEMBER 13, 1992 INSPECTION WAS ACHIEVED WITHIN THE REQUIRED NINETY (90) DAY PERIOD, AND TECHNICAL WELDING LABORATORY, ST. CROIX WAS IN FULL COMPLIANCE.

WE IMMEDIATLY INSTITUTED A NEW POLICY OF ONE PAGE PER INVENTORY PERIOD. PLEASE NOTE THE ATTACHED CORRESPONDENCE RELATING TO THE INVENTORY INSPECTION AND MAINTENANCE IN QUESTION FOR YOU RECORDS.

4) DATE WHEN FULL COMPLIANCE WAS ACHIEVED:

ACCORDING TO OUR RECORDS WE WERE IN FULL COMPLIANCE. AS STATED IN PART 3, WE HAVE IMPLEMENTED A MORE IMPROVED SYSTEM OF EXHIBITING INVENTORY INSPECTION AND MAINTENANCE.
