SUBJECT: NRC INSPECTION REPORT NOS 50-338/92-32 AND 50-339/92-32

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by Mr. M. Lesser of this office on December 20 - January 16, 1993. The inspection included a review of activities authorized for your North Anna facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed Inspection Report identifies activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B of the Enforcement Policy.
