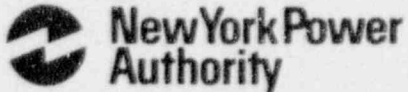

The FitzPatrick Technical Specifications contain several Limiting Condition for Operation (LCO) action statements which require the plant to be placed in the cold condition using various terminology for apparently identical actions. There is no guidance available to the operators on how to interpret these different requirements. This application adopts consistent terminology for LCO action statements and clearly distinguishes between the different actions associated with each LCO. This application also adds action times to action statements that previously did not specify action times.


