Dear Mr. Borchardt:

Attached is a copy of WCAP-13054, Rev.1 (non-proprietary) "AP600 Compliance With SRP Acceptance Criteria," dated January 1993.

The original issues of WCAP-13053 (proprietary) and WCAP-13054 (non-proprietary), "AP600 Compliance With SRP Acceptance Criteria" were submitted to the NRC in August of 1991. These WCAPs addressed the AP600 compliance with the acceptance criteria for each section of the Standard Review Plan (SRP), NUREG-0800. Although those reports reflected the AP600 position at that point in time, in some instances the AP600 position has changed as the AP600 design progressed.

With the subsequent filing of the AP600 Standard Safety Analysis Report (SSAR), information previously considered proprietary in WCAP-13053 has been provided in the SSAR. Therefore, the nonproprietary (WCAP-13054) version of the "AP600 Compliance With SRP Acceptance Criteria," has been revised to reflect the design described in the SSAR and to release information previously considered proprietary in WCAP-13053. As such, the information provided in WCAP-13054, Rev. 1 supersedes the information previously provided in WCAP-13053 and WCAP-13054. The NRC copies of WCAP-13053 should be destroyed.
