SUBJECT: CONFIRMATORY ACTION LETTER

It has recently come to our attention that Sacred Heart Hospital has not submitted to the NRC a Quality Management (QM) Program as required by 10 CFR 35.32. This QM Program should have been submitted by January 27, 1992.

Pursuant to a telephone conversation between Dennis Sokol of your staff and William L. Fisher of this NRC regional office on March 4, 1993, it is our understanding that you have taken or plan to take the following actions (which will be completed by the dates specified):

1. Within 30 days of the date of this letter, you will submit to this NRC regional office a Quality Management Program as described in 10 CFR 35.32.
2. You will ensure immediately that licensed activities at Sacred Heart Hospital comply with the provisions of 10 CFR 35.32(a)(1) through (5).

Pursuant to Section 182 of the Atomic Energy Act, 42 U.S.C. 2232, and 10 CFR 2.204, you are required to:

1. Notify me immediately if your understanding differs from that set forth above;
2. Notify me if for any reason you cannot complete the actions within the specified schedule and advise me in writing of your modified schedule in advance of the change; and
3. Notify me in writing when you have completed the actions addressed in this Confirmatory Action Letter.

Issuance of this Confirmatory Action Letter does not preclude issuance of an order formalizing the above commitments or requiring other actions on the part
