## INTRODUCTION

### Organization

The Historical Data Summary of the Systematic Assessment of Licensee Performance (SALP) is produced periodically by the U.S. Nuclear Regulatory Commission (NRC). This summary provides the results of the assessment for the period July 1, 1992 through December 31, 1992. The results are presented for each facility in three sections and are further divided by NRC region. Section 1 presents the most recent SALP report ratings for facilities in operation and under construction. Section 2 presents a chronological listing of all SALP report ratings for each operating facility. Section 3 presents a chronological listing of all SALP report ratings for each facility under construction. For historical purposes, past construction SALP ratings for facilities that recently have been licensed also are listed in Section 3.

### Background

The SALP program is an integrated NRC staff effort to collect and evaluate observations and data to assess and better understand the reasons for a licensee's performance. The program is described in Manual Chapter 0516, which was revised in June 1988, in August 1989, and again in September 1990. The purpose of the program is to assess licensee performance in selected functional areas. Prior to the June 1988 revision to the Manual Chapter, the areas for facilities in operation generally included plant operation (OPS), radiological controls (RADCON), maintenance (MAINT), surveillance (SURV), emergency preparedness (EP), fire protection (FP), security (SEC), outages (OUTG), quality programs and administrative controls affecting quality (QP), licensing activities (LIC), and training and qualification effectiveness (TRG). These functional areas were revised in number and scope in the June 1988 revision. For facilities in operation that have been evaluated since the June 1988 revision to the Manual Chapter, the areas generally include plant operations (OPS), radiological controls (RADCON), maintenance/surveillance (M/S), emergency preparedness (EP), security (SEC), engineering/technical support (ET), and safety assessment/quality verification (SQ).

The functional areas for facilities under construction, prior to the June 1988 revision to Manual Chapter 0516, are soils and foundations (SF); containment, safety-related structures, and major steel supports (CONT); piping systems and supports (PIPE); safety-related components (SRC); auxiliary systems (AUX); electrical equipment and cables (ELEC); instrumentation (INST); design engineering (DSN); quality assurance and administrative controls affecting quality (QA); and licensing activities (LIC). The functional areas under the June 1988 revised Manual Chapter 0516 are soils and foundations; containment, major structures and major steel supports; piping systems and supports; mechanical components; auxiliary systems; electrical equipment and cables; instrumentation; engineering/technical support; and safety assessment/quality verification. However, no SALPs of facilities under construction have been completed under the revised Manual Chapter.

Based on a review of the consolidated information, each evaluated functional area is placed into one of three performance categories. A Category 1 rating designates a superior level of performance where reduced NRC attention may be appropriate. A Category 2 rating designates a good level of performance where

NRC attention should be maintained at normal levels. A Category 3 rating designates an acceptable level of performance where NRC will consider increased levels of inspection effort. An "N" indicates that no rating was given for the category because of lack of meaningful data or the functional area is not appropriate for this SALP cycle. An "X" in place of a category rating indicates that a rating was not given for a reason other than that corresponding to an "N". The reason for an "X" is provided with a footnote in the SALP history and explained in detail in the SALP report.
