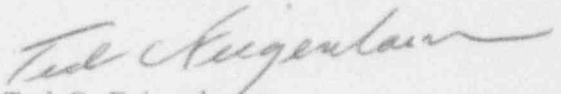
Subject: Onsite Property Damage Insurance
