SUBJECT: RESUMPTION OF SENIOR REACTOR OPERATOR LICENSED DUTIES  
PRIOR TO NRC NOTIFICATION

Thank you for your letter in response to our letter of November 2, 1992. Your letter dated November 20, 1992, provided an explanation of the circumstances that led to the occurrence of a senior reactor operator resuming licensed duties prior to NRC notification as required by his amended license.

We understand that GPUN has determined that inadequate GPUN administrative controls led to this occurrence. Since GPUN has taken actions to revise the administrative controls and GPUN is aware of the need to ensure all licensed operators comply with their license conditions, no enforcement action is planned.

Attached is a nonproprietary copy of our letter to the subject operator.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the Public Document Room (PDR).
