Subject: Confirmatory Order Modifying License

We have received your letter of April 29, 1993, to Mr. Thomas T. Martin, Regional Administrator, Region I. In your letter you stated that Yale-New Haven Hospital had retained the services of Drs. Brodsky, Ling, and Sternick to perform an independent assessment of your radiation safety program. Your letter enclosed curriculum vitae for these individuals for our review and approval.

As was discussed during a telephone conversation between Mr. James P. Dwyer of my staff and Mr. Michael Bohan of your staff on May 5, 1993, Section V.A of the subject Order does not require NRC approval of the individuals you have retained to perform the independent assessment of your radiation safety program. Section V.A of the Order only requires that you retain the services of an expert, independent of your staff, with extensive experience in the management and implementation of a broad scope radiation safety program to perform an assessment of your radiation safety program, and that you submit the name and qualifications of the expert to the Regional Administrator, Region I, within 30 days from the effective date of the Order.

Based on our review of the information that you submitted in your April 29, 1993 letter, we believe that Yale-New Haven Hospital has met the requirements of Section V.A of the Order. The remainder of the Order remains in effect.
